Pros of Buying a New/Used Car!

- Eventual ownership
- Freedom from the pain of monthly payments
- After the vehicle is paid off, you're free to sell it at any
- You can drive at will
- Never having to worry about mileage limits
- No worries over minor mishaps like spilled coffee stains on carpeting or a dog-chewed seat belt
- You're free to modify and/or
- Insurance costs are generally lower than leased vehicles

Cons of Buying New/Used Car!

- · Monthly payments are higher than those of a leased vehicle
- Dealers may require a hefty down payment if your credit score is low
- Rapid depreciation, diminishing the vehicle's resale

With extended use, you can expect to incur repair bills

Pros of Car Leasing!

- Substantially lower monthly payments!
- Down payments, if at all, are small
- No up front sales tax fees
- No depreciation concerns
- Even with lower credit rating some leasing companies will still be willing to work with
- If you own a business and use the vehicle only for business purposes, you can claim it as a tax deduction

Cons of Car Leasing

- Higher insurance premiums
- You'll always have car payments
- · Penalties for exceeding allotted miles. This generally ranges between 15 to 25 cents per extra mile
- · Wear and tear fees, creating heightened concern when traveling with pets or small children

Notes on Leasing

The last 4 vehicles I have purchased were leased. Automobiles are depreciating asset's and financial experts say if you are going to replace your vehicle every 3-4 years then leasing is the way to go, provided you

drive less than 15,000 miles per year. At the end of the lease, if you love the car you can purchase the vehicle for the residual value, that is determined at lease inception. If not, there are a few options.

- 1. Drop it off at the Dealership
- 2. Trade it in and use your equity, to re-lease or purchase
- 3. Sell it and retain the difference between the payoff and the selling price

Traffic Q&A:

With the Beaverton Police Department

have noticed that more and more cars are equipped with these super bright white headlights, sometimes in different colors. It sure makes driving more difficult when the on-coming vehicles use these lights. Are these headlights legal?



A: Although there is a section in

the Oregon statute regarding headlight specifications (ORS 816.050), Oregon has adopted the Federal Department of Transportation's definition which does indeed allow for many of these kinds of headlights. Use of high beams or having misaligned lights that would shine into oncoming traffic is enforceable under ORS811.520 and/or ORS816.300.

■When stopped at a red light, I've seen people get **■out** of the car to switch drivers or get something out of the trunk before the light turns green. This must be breaking some law, right?

A: Actually, there is no violation here unless the light turns green.

In January a reader asked "When there is a flashing yellow left-handturn arrow at an intersection, is it OK to pull into the middle when waiting for oncoming traffic to clear? The initial answer left out some language in ORS 811.260 (13) which says:

A driver facing a flashing yellow arrow signal, alone or in combination with other signal indications, may cautiously enter the intersection only to make the movement indicated by the flashing yellow arrow signal or the movement permitted by other signals shown at the same time. A driver shall yield the right of way to other vehicles within the intersection at the time the flashing yellow arrow signal is shown. In addition, a driver turning left shall yield the right of way to other vehicles approaching from the opposite direction so closely as to constitute an immediate hazard during the time when the turning vehicle is moving across or within the intersection.
